HB1446 Paraphrase: HB1446, by Rep. Melissa Provenzano, D-Tulsa and Sen. Mary Boren, D-Norman, requires, if a student completes any required courses or sets of competencies in mathematics prior to ninth grade, for those to be counted toward the units necessary to fulfill mathematics courses required for graduation.

Darcy Jech, R-Kingfisher, requires the Department of Corrections to create for each correctional facility within Oklahoma an "Orange Alert" communication system to notify any resident within a radius of 40 miles when a prisoner of a correctional facility has escaped. It requires information regarding how to register for an "Orange Alert" via the communication system to be posted in a newspaper of record within the county in which the correctional facility is located.

HB1770 Paraphrase: HB1770, by Rep. Toni Hasenbeck, R-Elgin and Sen. Micheal Bergstrom, R-Adair, requires school districts to provide academic support for high school juniors and seniors who score below the benchmarks on the subject area portions of the ACT and SAT, including, among other things, extended instructional time during the day; a summer academy; tutoring; Online coursework; and repeating a course. It prohibits students receiving extra academic support from being excluded in extracurricular activities or from enrolling in CareerTech courses or programs.

HB1935 Paraphrase: HB1935, by Rep. Charles McCall, R-Atoka and Sen. Greg Treat, R-Oklahoma City, creates the Oklahoma Parental Choice Tax Credit Act. The bill states legislative intent. The bill defines applicable terms. The bill establishes a \$7,500 tax

credit per child for students in households with adjusted gross incomes of \$250,000 or less that attend a private school accredited by the State Board of Education or another accrediting association or the amount of tuition and fees for the private school, whichever is less, and \$1,000 per household for qualified expenses per taxpayer in each tax year if one or more eligible students is educated pursuant to the other means of education (homeschooled). It requires the taxpayer to retain all receipts of qualified expenses as proof of the amounts paid each tax year the credit is claimed and to submit them to the Oklahoma Tax Commission upon request. It permits the commission to prescribe forms for purposes of claiming the credits . It requires the commission to create a form for the purpose of allowing taxpayers to request that the credit amount be advanced to the taxpayer in two installments of not more than \$3,750 per semester or the amount of tuition and fees for the private school, whichever is less. It requires eligible taxpayers who submit the form and qualify for an advance to be approved and paid within 60 days of submitting the prescribed form. The bill permits students to accept a scholarship from the Lindsey Nicole Henry Scholarships for Students with Disabilities Program participating in the Oklahoma Parental Choice Tax Credit Program. The bill authorizes the Tax Commission to conduct an audit or contract for the auditing of receipts for qualified expenses submitted. It authorizes the Tax Commission to recapture the credits on a prorated basis if an audit shows that the credit was claimed for expenditures that were not qualified expenses or it finds that the taxpayer has claimed an eligible student who no longer attends a private school or has enrolled in a public school in the state. The bill requires the tax credit to be reduced proportionately to the reduction in the amount of money appropriated to the State Board of Education in the event of a revenue failure. The bill establishes requirements for taxpayers claiming the credits. The bill requires the State Department of Education to implement a commercially viable, cost-effective, and user-friendly system for users to publicly rate, review, and share information about education service providers. It requires the Tax Commission to coordinate with the State Department of Education to develop a process to review student enrollment information in order to verify that an eligible student who is claimed by a taxpayer receiving a tax credit is not enrolled in a public school in the state. It requires taxpayers be permitted to intervene for the purposes of defending the Oklahoma Parental Choice Tax Credit Program's constitutionality if it is challenged. The bill provides the act is not severable. The bill requires HB2775 to become effective in order for it to be effective.

HB2003 Paraphrase: HB2003, by Rep. Jeff Boatman, R-Tulsa and Sen. Ally Seifried, R-Claremore, allows the county treasurer to allow taxpayers owning taxable property within the county the option to prepay taxes levied upon an ad valorem basis using the prepayment option provided therein. It requires the prepayment option to allow taxpayers to make installment payments to pay toward taxes levied upon an ad valorem basis for the following fiscal year.

It requires a school to grant a request for access to professional development material within five working days, instead of a "reasonable period of time."

HB2089 Paraphrase: HB2089, by Rep. Jon Echols, R-Oklahoma City and Sen. Lonnie Paxton, R-Tuttle, establishes that municipal zoning decisions are legislative in nature and valid unless the ordinance is proved to lack a substantial relation to public health and safety or if it constitutes an arbitrary exercise of police power. It establishes that municipal platting decisions are quasi-judicial in nature and gives the Planning Commission and the City Council of a municipality the discretion to determine a plats compliance with regulations, codes, and ordinances. It provides that in the case of a preliminary or final plat denial, the objecting governing body member is required to identify their basis for denial. It allows comprehensive plans are to be used as a guide when making zoning or plat decisions, but decisions are required to be based on objective and relevant facts and municipal code.

The bill requires that each elected county assessor, first deputies, and all personnel, including contractors, involved in the appraisal of all energy producing properties, including petroleum, wind energy, and solar energy real property and personal property assets shall be required to successfully complete a course provided by the Oklahoma State University Center for Local Government Technology on the valuation of energy producing properties within twelve (12) months of the effective date of this act.

Chuck Hall, R-Perry, provides a tax credit to taxpayers that donate to a county road and bridges incentive account beginning tax year 2024 through tax year 2026. The credit amount is based on the population of the county in which the donation is made. It modifies the educational training requirement for county elected and appointed officials beginning November 1, 2024, which varies based on the position and population of the county. Failure to attend the required training will result in the forfeiture of their monthly travel allowance. It

requires the County Training Program Director to send written notifications of noncompliance to the State Auditor and county clerk and commissioners.

HB2285 Paraphrase: HB2285, by Rep. Mark Lepak, R-Claremore and Sen. Dave Rader, R-Tulsa, replaces the graduated personal income tax (PIT) rate structure with a flat 4.50 percent rate effective tax year 2024 and establishes revenue triggers that would reduce the PIT rate by .25 percent each year that certain revenue conditions are met. It requires that beginning with the February 2024 State Board of Equalization meeting and every February meeting thereafter, the board must compare the General Revenue Fund (GRF) collections for the upcoming fiscal year to a base year GRF collection amount and find that the total collections have increased by more 1.5 percent to trigger a rate reduction.

It requires the program be administered to increase the role of employer-sponsorship in the workforce training system, direct training expenses to actual industry needs and actual job placements and ensure that Oklahoma remains competitive in industries of the future.

HB2556 Paraphrase: HB2556, by Rep. Mark McBride, R-Moore and Sen. Brent Howard, R-Altus, removes the sunset date from Construction Industries Board. It adds home inspectors to the list of industries over which the board has authority, and it requires the board to implement and administer the Oklahoma Uniform Building Code Commission Act. It gives the board the power to enforce the provisions of the Roofing Contractor Registration Act, including, but not limited to, performing inspections of licenses, registrations, endorsements and construction sites not otherwise subject to code inspection for compliance with statewide adopted building codes applicable to the trades licensed by the board. It requires the board's annual statement of receipts and expenditures be delivered to the Senate and House committees having authority over matters relating to business, labor and construction industry licensing or regulation not later than February 1 each year if it is not otherwise available electronically on the website of the State Auditor and Inspector. The bill changes the deadline for all fines, penalties and fees assessed for any violation of law or rule to be automatically reviewed and brought before the entire board for consideration and vote. It clarifies language related to final orders of the board. It modifies the board's powers and duties related to the training of all residential and commercial building code inspectors. It modifies the board's power to adopt, amend, repeal and promulgate rules as may be necessary to perform the duties required under the Oklahoma Uniform Building Code Commission. The bill requires 10 percent of the gross permit fees charged, collected and received to be deposited in the General Revenue Fund. The bill repeals language related to the board's chief executive officer and the requirement that the Attorney General be the legal advisor for the board.

Adam Pugh, R-Edmond, permit, beginning with the 2023-2024 school year, the statewide student assessment system to include a retest of the nationally recognized college- and career-readiness assessment administered pursuant to subparagraph b of paragraph 2 of this subsection, or nationally recognized, portable career-readiness assessments that lead to a National Career Readiness Certificate. It requires the assessments be available for students in the fall semester of their twelfth grade year and be administered at no cost to students.

It clarifies that local school districts, the Oklahoma Department of Career and Technology Education, institutions of higher education, or a private entity may hire or employ designated examiners for the Class A, B or C driving skills portion and written portion of the test required for a driver license.

HB2775 Paraphrase: HB2775, by Rep. Charles McCall, R-Atoka and Sen. Greg Treat, R-Oklahoma City, appropriates \$500 million from the FY2024 General Revenue Fund to State Board of Education. It increases the minimum teacher pay schedule in the following increments: \$3,000 for teachers with 0-4 years of experience; \$4,000 for teachers with 5-9 years of experience; \$5,000 for teachers with 10-14 years of experience; and \$6,000 for teachers with 15-25 years of experience. It creates the Rewarding Excellent Educators Revolving Fund and appropriates \$30 million from the FY2024 General Revenue Fund to it. The bill creates the Rewarding Excellent Educators Grant Program to provide grants funds to school districts to implement qualitative bonus pay plans for eligible teachers and eligible support employees. It requires school districts boards of education, in order to receive grant funds to approve and submit to the State Department of Education a qualitative bonus pay plan to reward high-performing eligible teachers and eligible support employees. The bill requires the plans include, but not be limited to, the following components: student growth, as defined by the school district board of education; peer evaluations; administrator evaluations; mentorship participation; and participation in extra responsibilities or duties. The bill requires the department to award grant funds to school districts from the Rewarding Excellent Educators Revolving Fund on a first-come, first-served basis until the funds appropriated are exhausted. It requires the grants awarded be used to provide one-time bonuses to eligible teachers and eligible support employees. It provides that no more than 10 percent of a school district's eligible teachers and eligible support employees may be provided one-time bonuses for the school year. It set the maximum bonus at \$5,000. The bill modifies certain weights in the School Aid formula.

SB0027 Paraphrase: SB0027, by Sen. Dewayne Pemberton, R-Muskogee, adds the option of a composite score of 1110 or higher on the SAT to the qualification requirements for the Oklahoma Higher Learning Access Program (OHLAP) for students who have graduated within the previous three years from a high school not accredited by the State Board of Education. It permits students who have completed the core curriculum and are seeking admission to a technology center school overseen by the State Board of Career and Technology Education to qualify for OHLAP.

SB0086 Paraphrase: SB0086, by Sen. Chuck Hall, R-Perry and Rep. The bill permits the board to issue special and limited obligations on behalf of the institutions supervised and managed by RUSO for purposes of such capital projects deemed proper. It authorizes the board to pledge any lawfully available source of revenue, other than revenue appropriated by the Legislature from tax receipts, but inclusive of revenues derived from the Oklahoma Education Lottery Act, accruing to the credit of institutions supervised and managed by RUSO to the repayment of obligations issued.

SB0093 Paraphrase: SB0093, by Sen. Dave Rader, R-Tulsa and Rep. Anthony Moore, R-Clinton, requires students complete and submit a Free Application for Federal Student Aid (FAFSA) in order to graduate from a public high school accredited by the State Board of Education. It provides for certain exemptions. The bill requires the State Department of Education develop and publish materials for students, parents, and legal guardians explaining the requirements to complete the FAFSA, the benefits to completing the FAFSA, and the opt-out provisions and an opt-out form to be used by school districts, charter schools, and virtual charter schools. It requires the superintendent of each school district to designate a school employee to collect information regarding student compliance with bill's provisions and requires the collection and storage of the information comply with the Family Educational Rights and Privacy Act of 1974 (FERPA). It requires the State Board of Education to promulgate rules that address the method by which a student is to provide proof to a school district, public charter school, or virtual charter school that the student has completed and submitted the FAFSA as required.

SB0100 Paraphrase: SB0100, by Sen. Dewayne Pemberton, R-Muskogee, requires every school district undergo a risk and vulnerability assessment conducted by the Oklahoma School Security Institute by July 1, 2026. The bill requires the assessment include recommendations to increase security on school district property. It exempts schools districts that underwent a risk and vulnerability assessment conducted by the Oklahoma School Security Institute in the two years prior to the effective date of the bill. It requires school districts to coordinate with the Oklahoma School Security Institute to conduct

reassessments every five years.
