HB1078 Paraphrase: HB1078, by Rep. Ken Luttrell, R-Ponca City, requires applicants for the journeyman plumber examination be 18-years old with 18 months of experience in the plumbing trade.

HB1379 Paraphrase: HB1379, by Rep. Tom Gann, R-Inola, reduces the votes required to approve a project plan to a majority of voters in the applicable district from two-thirds of the governing body which is in accord with the recommendation of the review committee. It requires the question for creation of the district, plan or project to be submitted to a vote of the eligible voters of the county if the district, plan or project is sponsored by the county. It requires the question for creation of the district, plan or project be submitted to a vote of the eligible voters of the applicable city or town if the district, plan or project is sponsored by a city or town.

HB1429 Paraphrase: HB1429, by Rep. Mark Vancuren, R-Owasso, creates the Campus Accountability and Safety Act. The bill requires each postsecondary education institution that receives any Title IV funding from the United States Department of Education, and the law enforcement and criminal justice agency located within the county of the campus of the institution enter into a memorandum of understanding to clearly delineate responsibilities and share information in accordance with applicable federal and state confidentiality laws, including but not limited to trends about sexually oriented criminal offenses occurring against students of the institution to share specific investigative responsibilities, trainings and requirements for issues related to sexually oriented criminal offenses to share information and training in order to improve campus safety. The bill sets specific responsibilities for institutions of higher education,

including creating a Uniform Policy on Sexual Assault addressing sexual crimes and mental and physical health of victims, and designate specific confidential advisors. The bill sets responsibilities for confidential advisors. The bill directs the State Regents to determine the adequate number of confidential advisors for an institution, based upon its size, no later than January 1, 2024. The bill requires each institute provide certain information for victims on their website. The bill allows online confidential reporting systems and requires an amnesty policy for students who report sexual violence in good faith. The bill directs coordination between The Oklahoma State Regents for Higher Education and the Attorney General. The bill requires communication between institutes in regards to transfer students against whom disciplinary action has been taken and requires that institutions withhold transcripts of students seeking a transfer with pending disciplinary action relative to sexually oriented criminal offenses, until such investigation and adjudication is complete. The bill requires, dependent on funding, each state educational institution shall administer an annual, anonymous, voluntary sexual assault climate survey to its students.

It requires information regarding how to register for an "Orange Alert" via the communication system to be posted in a newspaper of record within the county in which the correctional facility is located.

It allows for the transfer of employees and requires OMES to coordinate the creation of the Department and transfer of records, property, equipment, assets, funds, allotments, purchase orders, liabilities, and outstanding financial obligations.

It requires the resolution to be submitted to registered voters of the county at a countywide special or general election. It requires that when a district is organized, it will have the powers conferred by the Oklahoma Hazard Mitigation Assessment District Act.

It requires the prepayment option to allow taxpayers to make installment payments to pay toward taxes levied upon an ad valorem basis for the following fiscal year.

HB2071 **Paraphrase:** HB2071, by Rep. The bill states if this happens for four consecutive years then the district must increase compensation for all teachers in the school district by 2 percent for each year the district failed to increase instructional expenditures.

violation and the institution's investigation, including but not limited to exculpatory evidence, statements by the accuser and accused student, third-party witness statements, electronically stored information, written communications, social media posts, demonstrative evidence, documents submitted by any participant, and the institution's choice of a video recording, audio recording, or transcript of any disciplinary hearing ultimately held in the matter but not including privileged documents or internal memorandums that the institution does not intend to introduce as evidence at any hearing on the matter. The bill requires a student code of conduct to include certain rights for students facing disciplinary action, including the right of representation and the presumption of innocence and the right to a hearing.

The bill sets a process for a local board of county commissioners to put forth a special election asking tax payer if they want to imposition of a severed net mineral acres tax based on certain requirements.

It gives the board the power to enforce the provisions of the Roofing Contractor Registration Act, including, but not limited to, performing inspections of licenses, registrations, endorsements and construction sites not otherwise subject to code inspection for compliance with statewide adopted building codes applicable to the trades licensed by the board. It requires the board's annual statement of receipts and expenditures be deliver to the Senate and House committees having authority over matters relating to business, labor and construction industry licensing or regulation not later than February 1 each year if it is not otherwise available electronically on the website of the State Auditor and Inspector. The bill changes the deadline for all fines, penalties and fees assessed for any violation of law or rule to be automatically reviewed and brought before the entire board for consideration and vote. It clarifies language related to final orders of the board. It modifies the board's powers and duties related to the training of all residential and commercial building code inspectors. It modifies the board's power to adopt, amend, repeal and promulgate rules as may be necessary to perform the duties required under the Oklahoma Uniform Building Code Commission. The bill requires 10 percent of the gross permit fees charged, collected and received to be deposited in the General Revenue Fund. The bill repeals language related to the board's chief executive officer and the requirement that the Attorney General be the legal advisor for the board.

HB2670 Paraphrase: HB2670, by Rep. Jay Steagall, R-Yukon, permits a parent to submit a written complaint detailing any violation of the statute related to parent involvement in public schools to the superintendent of the school district. The bill entitles the parent to a meeting with the

superintendent to discuss the complaint if desired by the parent. The bill requires the superintendent to investigate the complaint and respond to the parent in writing within 14 days after receiving the complaint describing the actions the superintendent will take to remedy the complaint. It permits a parent to appeal the actions of the superintendent to the Board of Education by submitting a written complaint detailing the violation and a description of why the superintendent's response failed to remedy the complaint. The bill requires the Board of Education to appoint a committee to investigate any the complaints. The bill requires the committee meet with the parent to discuss the complaint. It requires the committee, within 30 days of receiving the complaint, to submit a recommended response and proposed steps to remedy the complaint to the board for action at the next regularly scheduled meeting. It permits a parent or a district attorney with jurisdiction over the school district to file a suit and assert a violation of this section as a claim against the school district if the board's action does not remedy a complaint. It permits a parent or district attorney that successfully asserts a claim to recover declaratory relief, injunctive relief to prevent or remedy of a violation or the effects of such a violation, reasonable attorneys' fees and costs, and any other appropriate relief.

It modifies the requirements to graduate to include computer science or technology, engineering, aerospace, or aviation in place of computer technology.
